

Kenyataan Tawaran Tender / Sebut Harga

The quotation document will only be issued to contractors presenting the original **Registration Certificate** (PPK and SPKK) issued by CIDB.

Contractors wishing to participate in the above quotation are required to issue a Postal Order/Postal Money Order/Bank Draft of **RM10.00 (Malaysian Ringgit: Ten Ringgit Only)** payable to the Director-General of the Department of Irrigation and Drainage Malaysia as payment for the quotation document.
